

## Prepaid Gift Voucher Terms and Conditions

- 1. \*\*Validity Period\*\*
- The prepaid gift voucher is valid for use within 3 months from the date of issue.
- The voucher must be redeemed by the expiration date mentioned on the voucher. After this date, the voucher will no longer be valid.

## 2. \*\*Redemption\*\*

- The voucher can be redeemed for any product or service offered by Pet Corner Trading LLC at the prevailing price at the time of redemption.
- To redeem the voucher, present it at the time of purchase or enter the voucher code online at [Pet Corner store].
- The voucher is valid for a single transaction only and must be presented at the time of service.

- The prepaid gift voucher cannot be returned or exchanged for cash.
- The voucher is non-transferable and can only be used by the person to whom it was issued.
